The Chairman opened the meeting at 7.00 p.m.

1. County Durham Red Squirrel Initiative Presentation

It was **Resolved** to thank the Durham Red Squirrel Initiative for their presentation, however the council decided that they will decline the offer to clear grey squirrels from the Parish Wood at this time.
